APPROVAL OF CHANGE IN DEPARTMENTAL APPROPRIATIONS

WHEREAS, Iowa Code § 331.434(6) authorizes the county board of supervisors, by resolution, to increase or decrease departmental appropriations provided that none of the ten major classes of expenditures are to be increased; and

WHEREAS, the Decatur County Board of Supervisors has determined that an appropriation increase is necessary for the Clerk of Court Department due to an underestimated cost for DHS shared costs during fiscal year 2018; and

WHEREAS, there appears to be sufficient appropriations in Juvenile Detention & Shelter Care that would allow a decrease in that department's appropriations;

THEREFORE BE IT RESOLVED, by the Decatur County Board of Supervisors that the following appropriation change be made as follows:
